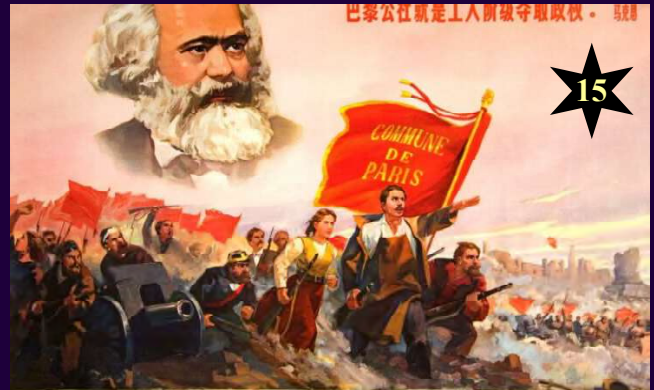

Today, the peasantry has opened the floodgates to the glorious struggle. The peasantry played a leading role in the struggle against colonialism. There were many uprisings across the country against the British rule. Played a historic role in the struggles against monarchy, feudalism, and imperialism. The peasantry has historically played a major role in the anti-British struggles from Punjab to Bengal and from Madhya Pradesh to Tamil Nadu in the south. The peasantry with such a fighting heritage is today fighting militantly against the three anti-farming laws brought by the BJP government. The peasantry, which fought against the British colonialists for land and self-government, is today fighting against these laws brought by the BJP government to fulfill the interests of the neo-colonial, pro-imperialist, comprador bourgeoisie. The peasantry, realizing that the government would grab their lands through these three laws, went into a fight with great perseverance.

The peasant struggles, which have been going on for more than six months, are enchanting the BJP government, which thinks it has not faced them. This struggle embarrassing the imperialists and comprador bourgeoisie.

These laws give a firm grip on the agricultural sector in the country to corporate and multinational companies. International and domestic corporates are empowered to make investment decisions regarding land in the hands of the farmer. The process of accelerating the loss of their lands and turning them into laborers will accelerate the poor and middle class farmers in the country. Small and medium-sized farms become unprofitable, leading farmers to go bankrupt and sell their land. The series of suicides, which have already registered over three lakhs, will be further intensified. Small farmers are displaced from their lands as the global organized retail sector is trapped in a trade and global supply chain. Retail goes into the

hands of corporate companies. So that the markets (mandis) of the country are closed. The farmer loses the opportunity to sell the crop the way he likes. In addition, the government will cancel the support price available to the farmer. As the contract system in agriculture is strengthened, farmers lose their rights to land and produce. Thus the peasantry is not only deprived of traditional land rights and habitations but also socially dependent on the agrarian economy and is pushed into a state of destruction. This angered the peasantry with the concern that the situation was going to fall from the dig into a well.

The imperialists and their multinational corporations are plundering the backward and developing countries of Asia, Africa and Latin America in many ways. Document released by the World Bank on India as part of Thatcher and Bush's neo-liberal policies, that had passed at Uruguay known as the 'GATT' agreement to maintain control and exploitation in the



agricultural sector which has to be implemented now. As a result, the agricultural sector of these countries has become paralyzed.

It is to get out of the perpetual crisis facing imperialism. Keep trying in many ways. Yet it continues to be subject to further crisis over time. The economic and financial crisis that began in 2008 is deepening and paralyzing imperialism. To get out of this crisis imperialism is desperately trying to seize the resources like genetic resources, forests, land, water, thereby lifting the restrictions on them to achieve super profits. As part of this, multinational companies are keeping an eye on resources in backward and developing countries. Billionaires like Bill Gates and the Amazon company, along with Reliance Ambani and the Adani groups, have taken over large-scale farmland for profit. For that BJP government has enacted new laws.

According to a study in the past "Agriculture has historically been seen as a low-income risky venture. It has changed in recent years. The food system is seen as a sector that guarantees long-term growth". That is why these investor vultures turned their attention to the agricultural sector. In line with this, the

World Bank has dedicated its Annual Global Development Report (WDR) - 2008 to agriculture. The report said 'The time has come to take agriculture into the development agenda. The opportunities and challenges that arise will take into account different contexts. "However, we are not discussing the challenges here. The World Bank and the comprador bourgeoisie have sought to restructure the Indian agricultural sector for investment purposes. Land confiscation from peasants, for the purpose of industrial, infrastructural, mining, real estate in the previous occasions. This new policy paving the way to imperialists & comprador bourgeoisie for obtaining full rights on lands and remold the sector as their purpose.

Land titling is for to benefit the multinational corporations

They are saying that creating power full land selling markets to reconstruct the agricultural sector. In 2015, Niti Ayog proclaimed, "that in India peasants have no land titling." The ownership is hypothetical, and will not stand in court. This reason, the owner is not getting real value for his land, due to this power land market did not arise. In addition to that, for his survival, the land is also so small and can't sell in market. For the

change of this condition, the government is trying to create power full land markets, in which it will bring land 'titling system' against the cultivators, the government is going to arrange permanent right to title(patta) holder. To easily selling, the government is framing land titling law.

Lands in the hands of tenants in the country, lands in the hands of those who have benefited from land reforms, as well as forest lands in the hands of tribals, government lands in the hands of the poor, houses distributed to the poor. A conspiracy was started to evict them from the lands as their rights over things like lands were unclear. All these lands are being encroached upon by industrialists and landlords. The government guarantees those graduates by recognizing them as landowners and giving them a degree without recognizing the rights of the poor, small and marginal farmers. And now the man is preparing to sell the land freely in the land market, all of them old and new types of landlords, capitalist landlords, rich and upper class peasants, farm house owners. The land could be taken over by large corporate companies without government intervention. They see to it that the problem of land rights is reduced to a purely administrative problem and that the efficiency of the land administration system is improved. Land belongs to the poor just because it is seen as a social issue rather than an administrative issue. But on the contrary, for the benefit of corporates, the Modi government during its first term tried to water down various provisions of the Reorganization and Rehabilitation Act-2013 and

remove them altogether if possible. In favor of corporates, the Karnataka Land Reforms (Amendment) Bill 2020 provides for two sections from the Land Reforms Act Section 79A, which allows only those earning less than Rs 25 lakh to purchase agricultural land, and Section 72 B, which allows only those whose livelihoods depend on agriculture to purchase agricultural land, have been removed. Now the Central and State Governments are enforcing this land title law under various names. Conducting land survey in Telangana and launching Dharani portal are also part of this.

Both the legislation passed during Modi's first term and the design of the current agricultural laws are in line with World Bank guidelines. The use of computerization, consolidation, records, and manuscripts should be expanded to bring the whole earth into account. A basis should be provided for registration of all places across the state. Private sector participation in the survey should be allowed. The government should focus its attention on control. Finally, the World Bank has legitimized the leasing of land, saying that "restrictions on land markets and restrictions on leases should be removed.

It should allow investors to acquire agricultural land directly (i.e. without government intervention). As a result, all the rights of the tenants to the lands acquired by the very poor in the land reforms will be abolished. Loss of power over lands acquired by tribal under the 2006 Forest Act. Millions of tenants in the country lose their small plots of land owned by the poor and become full-time laborers. The lands of small and middle class farmers are being marketed and their lands are being encroached upon by big landlords, corporates and multinationals.

The UPA government launched the Land Records Modernization Program (NLRC) in 2008 with the aim of enacting the "Land Titling Act" as part of the process of converting land into full commodity. It was revived by the Modi government in 2014 as the "Digital India Land Records Advanced Program" (DIL RAP), which has been shouting "Digital India" ever since Modi came to power. He is telling that these farming laws should have been enacted 15 years ago. During the first term of the Modi government, he could not implement the Rehabilitation Act-2013 due to the opposition of people and opposition parties. Taking the advantage of corona crisis, he made these 3 farming laws.

During the implementation of the Lock Down in April 2020, the Prime Minister launched a new scheme called "Swamitwa" to map all residential areas in the countryside by drone surveys, which will not benefit the homeless, making it easier to 'parcel the land in the market'. The government says it will increase the status quo of selling and making money. In the wake of the World Bank, all the ruling parties, including the BJP and the Congress, have been making strenuous efforts to alienate the farmer from their own lands.

Digital technical companies entering into India

These companies are trying to take control of Indian agriculture as agriculture is no longer profitable in countries like the US, and tech companies are coming forward with new technologies to invest in agriculture, such as Amazon, Google, Macros, Facebook. All of them have already become new land lords with investments in agriculture in the United States, Britain and other countries. In America Bill Gates and his estranged wife Melinda own 2,68,940 acres of land. Their Foundation provides billions of dollars in financial assistance for high-yielding sustainable development in other South Asian and African countries, including India. They are more likely to gradually take over lands in these countries. Their foundation is active in Bihar in our country. Also Microsoft is building a digital farming platform called Ezur Farm Beats based on its Ezur Cloud computing technology. It is developing driverless tractors, planting, mowers, insecticide drones and sensors with technologies such as artificial intelligence. Amazon boss Bezos also owns 4,20,000 acres. Facebook has invested Rs. 44,000 crore in Jio platforms in India. Facebook



- already playing a leading role in agriculture in India. The most used technology by Indian farmers is Facebook and its affiliate WhatsApp. The farm appliances, driverless tractors and drones provided by these huge tech companies can be used for cultivation in thousands of acres of cropland, but they are of no use to the 50 crore smallholders in our country.

Buyers, Syngenta, Kordona and Cargill, the agri-business companies that are already establishing in agriculture and exploiting the sale of pesticides, seeds, fertilizers, tractors, drones, etc. to farmers, are further strengthening their base. Newly emerging tech giants have teamed up with these giant tech companies to provide digital information on agriculture to those companies, as well as providing food consumer data. These digital tech companies are stealing the natural knowledge that farmers have acquired by farming for hundreds of years. Farmers' knowledge of land quality, natural seeds, climate change practices, and water use can be used to collect knowledge in the form of digital information, add new technology to it, and provide corporatization in agriculture to multinational companies rooted in agri business. Thus the combination of these two types of investments will lead to large scale corporatization in Indian agriculture and severe loss to agriculture.

Occupying farmers' lands by big tech companies, agribusiness companies, e-commerce, big industrial large tech companies, through e-commerce, converting them into big industrial farms and carrying out the process of farming with machinery and chemicals. All of these are under



the control of financial speculators. These multinational corporations are damaging environment and man's natural connection with the environment and nature. International retail giants are controlling the retail sector in India through e-commerce. In 2016, Wal-Mart took over Flipkart for \$ 3.3 billion. Currently in the Indian market, Wal-Mart and Amazon have tied the knot in the digital retail market, both in the retail sector. As a result, millions of small traders and retailers in the country are completely losing their jobs. Another important development is that the investments of organized retail large companies are encouraging unconventional exports in backward, developing countries. In particular, these investments are being made for the export of seafood, fruits, vegetables, flowers, nuts, meat and spices to imperialist and capitalist countries.

WDR 2008 estimates third world agricultural growth on this. This growth is called the new source of demand. "With the rapidly growing local and international demand for high-value agricultural products, it opens up significant new growth opportunities for the agricultural sector in developing countries. Emerging new agriculture is led

by private entrepreneurs who run extensive value chains that connect producers to consumers."

The OECD also stated that achieving self-sufficiency and food security through the major crops grown in India would not be possible and would be counterproductive. It said that importing staple food, exporting high value crops, participation in the international market and Agri-food have the potential to provide revenue growth opportunities through global value chains. Through this revenue the government and individuals can rely on imports for staple food. As part of this, the government is transferring money to farmers' banks as minimum income support under the Prime Minister's Kisan Yojana. To those extent removing fertilizer subsidies, lower tariffs on electricity, lower interest rates on bank loans would hurt agriculture and make farmers dependent on imports for food grains. The following developments come to the fore if one examines the agricultural laws brought in with the sponsored orders of the imperialists mentioned above. With the Agricultural Produce Market Committee (Mandis) closed and the official procurement of food grains

halted, farmers in areas with food grain surpluses will not be able to sell their crops at the minimum support price. Most of the food grains production will be affected with it. The food grain market is run by multinational companies and relies on imports. To this end, the Essential Commodities Act has been amended to remove restrictions on hoarding. Due to implementation of these policies a section of peasant community which depends on food grain production will switch over to other crops. This is the purpose of the new law regarding contract farming.



Organized retail business displaces small farmers. That is, retailers seek out large suppliers after becoming an organized retail procurement agency. Because dealing with big suppliers for them reduces all the costs of buying. It will be easier to standardize the product to suit larger retail needs. This makes it easier and cheaper to identify the product line for each product. The big producer will be able to buy different goods according to different criteria. The acquisition leaves small farmers bankrupt and displaced from their lands, replacing large-scale corporate farming. More over suppliers have to change their production processes to

suit the needs of the retail giants. As well as making significant investments. This can also lead to dismissal of smaller suppliers. Neither small farmers nor small suppliers can afford to be part of this global value chain. Multinational companies make agreements with powerful companies.

It will not be possible for small farmers or small suppliers to be part of these global value chains, unless multinational corporations enter into agricultural agreements with powerful companies that poor farmers will not be able to

afford. Not all land is suitable for such crops for products in high value agriculture. They continue to harvest major crops. In this order they earn less. This increases the debt burden of the farmer and eventually leads to the misery of having to sell the land. The public distribution system will be completely damaged and food security will be damaged as a result of the indiscriminate implementation of the predatory policies of the imperialists to close down the grain warehouses and rely on foreign imports. The impact of agricultural laws will also take its toll on dairy producers. 55 lakhs of marginal & small farmers, which are having one or two

cows, excluded from livelihood between 2000-2016 due to liberalization policy. This evolution is due to the easing of government control over the dairy sector. The market is well organized at all levels from the dairy to the consumer family. Large dairy companies benefited from the fall in prices in 2005-19, while small producers suffered large losses. The French company Lactalis has taken over Tirumala, Aniki and Prabhat Dairy companies in the last five years. Amul also grew up like this. But small, marginal farmers in Gujarat have suffered severely. The new agricultural laws will further accelerate and strengthen corporate control and monopolies over the dairy industry.

More than 60 percent of the people in India depend on agriculture. More than 80 per cent of them are small, marginal farmers. Up to 50 per cent of the laborers are employed in agriculture. According to the National Sample Survey 2012-13, the average household income from all sources is Rs. 6,400 per month. Their total income is less than the consumption expenditure. Also the number of indebted farmer families increased from 49 per cent to 53 per cent. 1.04 lakh on average. As a result of this poverty, 3.30 lakh farmers committed and suicides are continuing. On the other hand, according to the Oxfam report, the wealth of many billionaires in the country, including Mukesh Ambani and Adani, has increased by 35 per cent, while 84 per cent of households in the country are losing income at different levels. During the Corona period 2020, 170,000 people lost their jobs in April alone. We are now seeing international billionaires,



brokers like Ambani and Adani in the country stepping into the agricultural sector. Expecting the impending calamity to the peasantry, the farmers are now in agitation.

Nationwide agitating peasantry:

The Punjab Kisan Sanghs organized a seminar in Chandigarh in February 2020, knowing in advance that the Modi government was going to bring in agricultural laws. It was attended by intellectuals, activists and leaders of various parties. They discussed the damage caused by these laws and also devised a plan to combat them.

The farmers' demonstrations began on June 8, the day the Modi government introduced ordinances on three laws. Farmers' demonstrations continued in July and August. BKU(EU) organization was started the campaign covered 25 lakh people in 13 hundred villages in 14 districts under the slogan 'Pind Jagao, pind hailo' wake up the villages. One lakh, of which 26,000 women rose from this movement. On May 2019, ahead of visit to Chandigarh by Modi on General elections, KMSC was conducted demonstrations against plight of the peasantry.

On November 21, a Kisan rally was held in Delhi with three and a half lakh people, including

farmers, laborers, men and women. Millions of farmers, along with tractors, cleared the police barricades along the Punjab and Haryana border and reached Singhu, tikree on the Delhi border. Delhi police had prevented them from entering Delhi and that they should not hold demonstrations at the adjoining Bhurari ground or any other ground there. This enraged farmer Singhu, who was stationed on the road at tikree Border. Later tents were set up there and protests are still going on. Soon after, the Haryana peasantry also expanded the movement by opposing in various places. On November 27, a Uttar Pradesh farmer was deployed at Ghaziapur over the flyover. Apart from these, Mukesh Ambani's toll plazas, petrol pumps, shopping malls and Adani's godowns in Punjab and Haryana have been cordoned off at about 50 places.



Next they damaged to 1500 jio cell towers in Haryana and Punjab.

It is a great scene in history that millions of farmers are agitating in the freezing cold. They got a lot of support from the local people there. In addition, surrounding traders and minorities supplied food material to the agitating farmers and gave support. Minorities are also part of the peasantry so they are also actively involved in the movement. Farmers' cultural and arts programs were held at these venues to reflect the history of the day with the historical scenes of the peasant struggles against the Mughals and the British. On November 26, Bhagat Singh, a freedom fighter and socialist from his hometown of Khakarkala, also started agitation and gained anti-British spirit. On December 9, International Human Rights Day, the agitators demanded the release of intellectuals, scholars and students from jails. On November 7 discussions took place between AIKSCC and government. But these were not fruitful. With that, 31 organizations from Punjab together formed the Kisan Morcha and called for agitation with the demand to repeal agricultural laws. It was supported by groups such as

BKU(EU) and KMSC and added more legitimate demands. The government has held 11 rounds of talks with the union. These negotiations were not fruitful. The government has seen these talks being used to liquidate the peasant movement and waste time. The Supreme Court has also set up a committee on the issue. The committee was rejected by the kisan Morcha as it was against the will of the farmers. Farmers decided to hold a tractor rally in Delhi on Republic Day. Delhi Police did not give permission before the rally. With the intervention of supreme court, the tractor procession was permitted with certain conditions. Peoples obstructed with barricades and leaves option to farmers to show on roads. But police also set up barricades on the road to prevent the rally. The enraged peasant broke through the barricades and marched on. There were clashes with police during the rally. A farmer was killed in a police shooting. The BJP government claimed that the movement was pro-Khalistan, that it had a foreign hand, that it was the destruction of anarchist gangs, that it was misleading the middle class people in the country, and that it was spreading mud on the peasant movement. The government's plot failed when the peasant organizations condemned the propaganda. The peasant movement has been raging for more than four months in the face of Modi government conspiracies and gossips. The peasants are saying that they plant the seeds and harvest the crops.

Fighting shoulder to shoulder, the movement has garnered international support like never before, with the support of the Prime Minister of Canada, the debate in the British Parliament, the support of eminent celebrities such as Rihanna, and a movement led by eighteen-year-old Speedy native Greta Thanberg Toolkit. Already till now 300 above peasants martyred in this movement. Women are playing eminent role in the movement. Countrywide peasantry fight shoulder to shoulder. The movement gained international prominence when the booklet tweeted that it would help the Indian peasant movement, with the BJP government shocked and accusing some of the country's professionals of helping to make the toolkit. The NIA has made illegal cases against them. The BJP and the RSS attacked farmers' tents in Singhu and Tikree. The water supply and electricity supply were cut off. Barricades (with nails, walls, doors, etc.) in 4 rows were built. However, many lakhs of farmers are actively participating in these processions, which are celebrated by the village and village Maha

Panchayats. On March 26, four months after the movement began, the Kisan Morcha called for a nationwide strike. On the occasion of half a year movement the SKM has issued a call to success countrywide black day on May 26, 2021 and it was very successful.

Dear people, peasant friends!

After the Fascist Narendra Modi government came to power for the second time, he was aggressively implementing the imperialist, comprador bourgeois-sponsored programs for the formation of a Hindu state. Kashmir is clinging to imperialists who have betrayed the people of the country by taking many decisions like draining autonomy, construction of Ram Mandir, Citizenship Amendment Act, violation of labor rights, curtailment of freedom of the press, amendments in the by-laws, various changes in the Parliamentary Laws, implementation of GST, demonetization. Now he is bringing forward agricultural laws and causing serious damage to Indian farmers. At the same time, he is laying a red carpet for the imperialists, inviting one hundred percent investment in many important industries in the public sector. People from all walks of life are making militant movements against these anti-people, fascist policies. Yet the Modi government is looking to suppress these movements with police forces. Regardless of the militant mass movements, this fascist law continues to be enforced. He is threatening the farmers that there is no point in withdrawing the agricultural laws under any circumstances. The peasantry must continue the uncompromising struggle until the agricultural laws framed by the Modi government are withdrawn. However, the withdrawal of these laws by the government will not completely solve the problems of the farmers. Therefore, the peasantry, workers, students, women, races, minorities, intellectuals, journalists and democrats who are victims of the laws, decisions and restrictions enforced by the BJP government must fight militantly and bury the Modi government and the Brahminical Hindutva fascism. While fighting against the ruling classes that are holding India hostage to the imperialists, the people of the country must now fight together against the common enemy of imperialism and neo-colonial policies of exploitation. The Indian people will be liberated from all forms of exploitation only by overthrowing the already rotten system of imperialist, comprador bourgeois and big feudal ruling classes and making the new democratic revolution a success. Hail the sacrifices of Indravelli martyrs - Let us uphold the 40 years' legacy of Indravelli Adivasi struggle.

The dictatorial governments, which are in the service of imperialists, comprador bourgeoisie and feudal forces, ever year deploying police & paramilitary forces and imposing bans, onslaught on people to stop the gathering at Indravelli monument, but the people defy the police restrictions and marching towards with fighting spirit of Indravelli martyrs vowing to pay tribute and pursue their aspirations to the last.

This year marks the 40th anniversary of the Indravelli struggle. This struggle still serves as a torchbearer for the fighting spirit of the tribal people. The time gap between Jode ghat struggle led by Komuram Bhim and the Indravelli struggle is forty years. After forty years, the Indravelli struggle may have been a coincidence in historical time, but history continues to be a thread. This struggle continues through twists and turns. The tribal struggles in the Adilabad United District have historically been of paramount importance. In the kingdom of Gondwana, Chanda as its headquarters, the tribals constantly fought for their power against the Bonsley (Maratha kings) and the British. Although, the British conquered the kingdom of Gondwana in a two-century struggle, they were unable to maintain complete dominance over the tribal inland areas. Although the colonists left the country and gave the country

fake independence, the rulers who are currently ruling the country are still wielding power based on the tribal chiefs (Mokashi) of the British period. The Nizam occupied the Adilabad Gond areas, which had its center Sirpur (Mankgirh) situated south bank of the Vardha River next to the Chanda kingdom at the time of Gondwana War. Since then the struggle against the Nizam king has continued in Adilabad district.

Adilabad district is located in the foothills of the Godavari River in northern Telangana. This vast district has a lot of forest cover. Teak wood and bamboo are abundant in these forests. Situated in the Godavari basin, the district is rich in fertile black soil lands. Small rivers like Swarna, Satnala, Vattivagu and Kadem flow through many hills and meet at Godavari. Maize, lentils and cotton are the major crops grown in the soil gram lands. Multinational companies seeking these lands introduced seed crops. With the advent of soybeans, farmers also started cultivating them. Cottonseeds originated in the early 1900s in neighboring Maharashtra. The Nizam also promoted this crop. In the hills, the tribals also cultivate cotton along with maize and red gram. Sorghum bread and lentils are the staple food for the tribals. However, in 1985, the government introduced rice at Rs. 2 per kg. From an onwards rice also joined as their food along with sorghum.

Komaram Bheem's struggle against Nizam

The Nizam king introduced a system of *makte* in Adilabad district to consolidate his power. The Nizam, for the consolidation of his authority, for the exploitation of land, forest produce and to collect taxes, he encouraged migration from outside in to the district. Bhamahins, Muslims, Velamas, largely entered in to the district. With these migrated people, he appointed *makedars* (tax collected persons). These *makedars* forcibly collected revenue from the people, which cultivate crops on fertile lands in the banks of Godavari river. Migration took place from Maharashtra, as it is adjacent to Maharashtra. As part of that the Brahmins, business community first entered the district and then Lambadis.

The Adivasis, disillusioned with the exploitation of the Nizam's monarchy, feudal and business classes, revolted against the Nizam under the leadership of Komuram Bheem. He led an armed uprising to gain power over the forests and land, as well as state power for the tribals. Inherited from Ramjigonda, the struggle sparked a fighting spirit among the tribals. Eleven fighters, including Komuram Bheem were martyred in the brutal massacre of the Nizam's forces. But Komaram Bheem, who led this struggle, remained in the tribal hearts and today remains a symbol of his struggle in the state of Telangana.

From 1860 onwards slowly the Lambadis began to establish

permanent settlements in the district. This is because after 1976, their immigration population increased to thousands and two million. They illegally acquired the lands of the Gonds. Forest lands were cut down and many villages were formed. The latter got the bulk of the tribal reservation quota and did so without equal opportunity for the Gonds. Even among the tribals they are bound to fight for the quota to be obtained in reservations at present in the wake of the growth of education with increased vigor after the Indraveli struggle. The Komuram Bheem struggle of the 40s revived the Adilabad tribal (Gondula) vigour and stinc in Indravelli peasant uprising.

Enter the “People’s War Party “into the tribal heart land

The revolutionary party excavated Komuram Bheem heroic Jode ghat struggle’s history confined to the tribal areas, made it into a historical novel, widely circulated among the Telugu people. The fight once again erupted in the Indravelli hills.

To quell the anger of the tribals, the Nizam appointed Heman Darf in the Adilabad district to explore the causes of the tribal rebellion. He lived and studied in the tribal villages of Adilabad and actually made some recommendations. These are not implemented at large. The situation of the tribals was nothing change. By the time of the Indravelli struggle the situation of the tribals had become miserable. Exploitation and atrocities merchants, forest officials, landlords and police have increased. In the 70s the People’s War Party began to build a revolutionary movement among the tribals. Under the party leadership, the tribals rallied and prepared for struggle in 1978, Adivasi people raided a big number the houses of merchants in Kamana village in Asifabad taluka and brought bulls. The bulls of tribals were forcibly snatched away by the merchants in exchange for debts. Such bulls were brought in by the peasants and the debentures were burned. This uprising created a sensation in the state. News of the struggle spread like wildfire across the tribal areas. Tribals were organized across the district under the Tribal Farmers Association.

The struggle for land began throughout the district. Forest officials were running away from the villages. When

the police attacked the villages, tribals would blow the traditional instrument ‘Thudum’ and prepare the people for the fight and resist the police. Thus the struggle escalated and the power of the peasant unions was established in the tribal villages. All the tribal areas were overrun with anti-g o v e r n m e n t struggles.

Every year in the month of Magha, a ceremony is held in the village of Keslapur to worship Nagoba, the tribal deity. It is also known as the Keslapur (Nagoba) Fair. (Dandari dance is the

specialty of this fair) The adivasis wear peacock feathers on their heads with various costumes and perform their cultural dances for a month by ringing traditional instruments in all the hamlets. The newlyweds wear wedding dresses and fetch water from the Godavari and perform pujas according to their custom. This concludes the fair. (Apart from the tribals of Telangana, thousands of tribals from different states also come to this fair.) According to Heymandorf, the Darbar is organized by the government here on the occasion of the fair, in which the Collector on behalf of the government receives applications on their issues from the tribals. Heman darf thought of it as a platform for solving people’s problems. But gradually the platform was weakened by the government. The aborigines boycotted the collector meeting on this platform for two years 1980-81 and held a darbar under the leadership of the tribal organization.

Indravelli Massacre

In Adilabad Indraveli became an important center after Asifabad for tribal struggles. The landlords and merchants

of Indravelli exploited the people immensely. Hence, there is opposition to them among the people of many villages in the area. Every fight that runs here has turned against these looters. The party has decided to hold a general meeting of the Tribal Farmers' Association on April 20, 1981. The adivasis wanted the Mahasabha to be held in Indravelli. The impact of the fighting fell on tribal villages covering an area of 30,000 square kilometers. The fighting extended from Sirpur in the east to Adilabad district to Kinwat taluka in Maharashtra on the border in the west. All the people of these areas moved to Indravelli Sabha.

On April 20, 1981, the government imposed Section 144 without giving permission to hold the Mahasabha of the Tribal Farmers Union in Indravelli. However, thousands of people flocked to Indravelli saying that the people had the right to celebrate the assembly. The government opened fire on people arriving in Indravelli for the meeting (as the British government had shot and killed people in Jallianwala Bagh) without warning, killing tens of tribals. The tribals resisted with militancy. The clash between police and tribals took place hours together by pelting stones on police, one woman attacked the police with sickle injured the police. The incident caused outrage among the people across the state.

Intellectuals, civil rights organizations, students and opposition parties condemned Indravelli massacre and give support the rights of tribals. Appealed for inquiry with supreme court judge but Government ordered Magisterial inquiry. 120 feet memorial monument was constructed in 1983, at the place where the tribal people were martyred. "People's heroes are immortal-Those mountains red, and the flowers red, oh! there is red, and our homage is red" - These words lines inscribed on the memorial pillar. As the legacy of martyrs, the tribal people are in continuous fight against governments for getting power on water, forest, land and self-respect.

The government did not permit the tribals to hold meeting to commemorate the martyrs who shed their lives for people at Indravelli memorial place. In addition to that prohibitory orders were clamped in

that area in 1986 the memorial pillar was demolished by the government. The NTR government rebuilt the memorial pillar due to pressure of people's movement. But the government did not permit to hold meet at that place for a long time. In recent time, it is giving to permissions to some selected people to pay homage to martyrs the fitting spirit of the tribals did not come down in these days also. The government is fearing for that type of threat.

Ban on party – government reforms

After the tribal upsurge, the government has strengthened ITDA to implement reforms in tribal areas to cool down movement. Hospitals and schools were introduced into the area. But the radical change did not take place in lives of tribals.

In addition to confronting with the repression, the party giving the leadership to tribal movement. The party had conducted the struggles for the right on the lands, drought problems, collective cultivation, cooperative groups, increasing the labor wages, minimum support price and established the people's power through tribal peasant organizations. The party had organized struggles with an aim to have power on water, land, forest, self-respect and liberation. It tried for the unity of tribal and non-tribal peasantry. Maintain unity with the poor people of Maratha, Lambada and Muslims fight against the non-tribal landlords. The party has involved the tribal people in NDR, besides fighting for the tribal people's rights. People's governmental committees were established. Nowadays this acting as revolutionary people's committees (RPC) in Dandakaranya.

Tribals could not get state power as themselves. They should must unite with the remaining people in the country to root out the state power of comprador capitalist class and landlord classes in the path of protracted peoples war. Some people who are against the party line, telling that the party does not solve the state power problem of tribals, only take up the land problem and also telling that right from the beginning the tribals of Adilabad have the consciousness of state power. This argument does not tell about the real state power of the tribals. They arguing of the tribal people with in the preview of 5th and 6th schedule of the constitution. To full fill task of new democratic revolution, in which the 4 classes – in leadership of working class should be dismantling the power of exploiting classes, establish the new democratic republic and after that advance to socialist path through class struggle. In this way the tribals of Adilabad has enriched the class consciousness of political state power which is best understanding them that of godwana power capture theory. But the oxford intellectuals and subaltern theorists are considering the ongoing class struggle as to get some rights with in the purview of 5th and 6th schedule and limited to partial autonomus. The government is now negating the constitutional rights, which were framed by the B.R. Ambedkar. Now, the

tribals are in a fight to get those rights along with fighting for real democracy. The pseudo- theories are a hindrance for the tribal people to get in to the real fight for power on land, water, forest and state power. However, the party is declaring that, “we are honestly fighting for autonomous status of nationalities, just separate state demands and democratic autonomous areas of tribals.

Tribals (Gonds) fighting with Indravelli sprit

In this 40 years the revolutionary movement has extended to various states. It has become challenge to the ruling classes. In Adilabad district the tribals are fighting with the spirit of Indravelli though, the generations changed. the emerging new leader ship leading the struggle in that process, martyre Sidam Shambu was emerged as a leader in 90's. Now, we can see the students and youth who are in the foot prints of Shambu.

The government implemented project of Haritha haram, Open cast mines, kavval tiger project are dangerous to the existence of tribals. Struggle is continuing against anti people projects. Within these 40 years, the tribal people are advanced to some extent in education sector. But they are not getting employment. Major chunk tribal reservation quota capturing by lambadas. This thing rises angry aganist lambadas. they are strengthening Rai centers and running schools them slevs. Besides that, the tribals are fighting unitedly.

On April 20, 2020, Indravelli celebrated the 39th Martyrs' memorial day with revolutionary spirit, not counting the bans, detention and lock downs. Indigenous people also held Indravelli meetings in 75 villages in the hinterland. The Indravelli legacy continues to be fought today.

Demanding forest land pattas (title deeds), 600 people blockaded the Maharashtra – Chandrapur national high way. With this the collector stepped down and immediately gave the pattas to 300 people and promised to give the rest to them within a month. People from 49 villages protested on the 16th high way demanding the repeal of the rules of the kavval tiger zone. 2500 people from 6 villages marched in protest against the killing of a tribal youth by forest officials and beat the forest officials and vandalized the forest office. Students, women and youths marched in procession and demolished buildings constructed with RCC in the agency area.

To enforce the 1/70 Act, the Pesa Act, to give pattas to forest lands, to show alternative lands to the settlers who lost their lands in the projects. Students, women and youths across the joint district staged four days of protests demanding the implementation of G.O no.3, the removal of lambadis from the ST list, the abolition of

atrocities by forest officials and the abolition of open cast mines that are destroying the environment and tribal life.

To crush the Maoist movement, the center and state governments implementing operation SAMADHAN – PRAHAR, in which arresting open organizations, cordon & search in the rural areas, filling the jails with rural people and clamping UAPA like draconian laws and terrorizing the entire rural area with large combing operations etc. their using informers network, coverts and planting cc cameras in villages. These operations are monitored by IG, SIB, DGP these officials are reviewing operations regularly to crush the movement. The cruel official, who were activity participated in previous times, are now posting in the movement areas.

The revolution in the district is being built in new ways. The government, which has been saying for the past few years that the Maoists will be suppressed and that they are not in the district, has admitted that the Maoist party will work among the people of the district by 2020, and has deployed thousands of police forces to crack down on the squads. With the extraordinary support of the people the squads continue their operations unhindered and lead the struggles of the people. People are also actively supporting the party, believing that their problems will be solved under the leadership of the Maoist party. The central and state governments, the BJP and the TRS, have been bowing down to imperialist, multinational companies, corporate powers, the feudal tyrannical comprador bourgeoisie and the ruling class and the repression of the movement. Even in such a difficult situation, the tribal people are fighting today for the power of Jal- Jungle - Zameen – Izzat and power in the spirit of Indravelli, uniting under the leadership of the party. keeping alertness on enemy and giving full protection to the revolutionary forces.

Looking at the history of the last 40 years, the people of Adilabad district have made many sacrifices and dedicated to the revolution. Many revolutionary activists were martyred in police encounters. However, the people of the district are building a glorious history of struggle, as witnessed by 40-year-old Indravelli. Time erase the marks of Injuries, but the memories are intact. The glorious Indravelli fighting spirit is still raging like a fermented nipple today. The flames of the movement will continue to blaze as long as tribal people fight to get power on forest, land, water and self-respect.

150 years to the PARIS COMMUNE

*'A great social revolution
that will liberate mankind
permanently through
class rule Paris Commune'*

... Karl Marx



By 1869 the working class in France had grown considerably. The progressive sections of the French working class broke away from bourgeois prestige and joined the Communist International. Anxiety grew day by day among the common people due to the dire conditions created by the endless hardship and poverty of the workers in the capitalist system. Houses, demonstrations, and strikes increased. People chanted 'Republic Zindabad' and 'Napoleon Murdabad'. The people of Paris survived and were ready to defend the capital of their republic.

People who understood the treacherous government policies immediately revolted once in October 1870 and again in January 1871. By February 1871 the population had grown and the Central Committee of the National Guard was formed in Paris. The people, together with the National Guard, arrested the military general and seized the guns.

March 18, 1871 Revolution - Establishment of the Paris Commune

At around 2pm on March 18, at the call of the Central Committee of the National Defense Force, armed men occupied the Orleans station and other bases in the city. The bourgeois government was overthrown. All power fell into the hands of the Central Committee of the National Defense Force. The new government formed the 'Paris Commune'. People greeted the commune Zindabad with jubilation.



Council elections are by universal suffrage. Commune activities were carried out with the scepter of workers, mass organizations of trade masses, trade unions, and revolutionary clubs. Women workers have helped the commune immensely. The commune council has become the highest authority in government. The same Paris Commune. Commune activities proved that the commune is a constitutional machine and the working class constitutional machine. The Paris Commune was the first working class dictatorship. In a short span of 72 days, the Paris Commune worked to consolidate the economy during the war and to improve the living conditions of working people. Those actions proved the Commune's responsibility and concern for the well-being of labor.

Their collective war against the Paris Commune began with the alliance of the French bourgeoisie with Germany. The all-out attack on the city of Paris began on May 20. There was a fierce struggle in the streets. The working class performed an unparalleled feat. For days a week from May 21 to May 28, people fought heroically and sacrificed their lives. There was blood on the streets of Paris. Comrade Eugene Pothiel, who after the defeat of the Paris Commune, wrote the

'International working class Anthem'.

Reasons for the defeat of the Paris Commune (identified by Karl Marx)

(1) Lack of revolutionary party structure is a big mistake. (2) Rely on the old government machinery. Reactions were not suppressed. (3) The enemy is not completely exterminated. Did not observe enemy war preparations. Versailles was not attacked. (4) More emphasis was placed on municipal elections and negotiations. Did not recognize that power does not come and stand peacefully. (5) The support of the frontier areas for Revolutionary Paris did not gather. The revolution did not spread across the country.

The influence of Blanque, a prominent follower on the leadership of the commune became paramount. Did not make proper use of the advice given from Marx 'International.

The historical significance of the commune - the commune had a tremendous impact on the international working class struggle. It sparked a communist movement throughout Europe. Proved the power of the Civil War. The commune taught the European working class to clearly determine the goals of the socialist revolution. Lenin described the experience of the Paris Commune, which Marx recognized as "a new kind of democracy, a working class democracy." He wanted to unite the working class leadership and continue the class struggle for a united government of oppressed classes. The Paris Commune was the first working class

dictatorship. It served as a model for the Soviet government.

With the formation of the Paris Commune, Marxism succeeded in defeating all the false ideologies of the working class movement and taking over the leadership position, so that even its enemies could disguise themselves as Marxists. Marxism clashes with this opportunistic revisionist tendency.

During the First World War (in 1917) the success of the October Socialist Revolution in Russia and the outbreak of national liberation struggles in the colonial countries plunged imperialism into a perpetual crisis. Human society has entered an era of revolutions. Contributed to the formation of communist parties around the world, the formation of the Third International, and the expansion of revolutionary struggles. During World War II, the People's Democratic States of Eastern Europe were established with the support of the Red Army, and the Mao-led (October 1949) Chinese Socialist Revolution was a success.

On the other hand, the crises of capitalism continued unabated until the 1970s, when the world economic and political policies pursued by the imperialists after World War II (via the World Bank, IMF) were temporarily recovered from the imperialist crisis. In Soviet Russia the counter-modern revisionist Khrushchev gang revived capitalism after 1956. It tore apart the world working class, the communist parties, the socialist camp. The Communist Party of China, led by Mao, defeated modern revisionism and led the working class cultural revolution in China, preventing the revival of capitalism. After 1976, however, the modern

revisionist Deng gang implemented liberal policies and transformed China into a capitalist country. The world has gone without a socialist camp.

Emerging as an unstoppable force in the imperialist camp after World War II, the American superpower faced Russian superpower competition for 2 decades after 1970 (until the fall of the Russian superpower in 1991). As the United States has been economically weak since the 1970s, so has its strategic weakness. The crisis of 2008 exacerbated it. China is a newcomer to world imperialism, and the United States is facing competition from countries such as Russia, Britain, France, Germany and China. America is gradually losing its supremacy.

The periodic crises of capitalism were replaced by the general crisis (permanent). It went through many stages and after the First and Second World Wars it was in a situation where it could not get out of the crisis again. No matter what kind of reforms investors introduce, they will not get out of the perpetual crisis. Keynesian theories and reforms New economic policies (LPGs) since the 1980s have not been able to pull themselves out of the crisis.

Capitalism today is facing a recession in production and investment based on historically unprecedented low interest rates, extraordinary accumulation of wealth in the hands of a few, large amounts of debt, drained world investment, and monetary investment speculation. Inequalities in wealth and income have risen to unprecedented levels. What is happening is that the earth is being made without a suitable place for man to live, damaging the global environment. The

global monopoly capitalism and the monetary system have become the main carriers of the new epidemic. Governments are enforcing large-scale sanctions in the form of neoliberalism and neo-fascism.

In the capitalist system, the competition has increased due to the monopoly capitalism. Economic inequalities have further increased. Wealth in one place, poverty in another, and class conflicts intensified. Now capitalism is in deep crisis. Goes deeper than the intensity of the 1930s. This was further exacerbated by the Kovid-19 epidemic. This has increased the concerns of the working class and other oppressed people around the world.

Unemployment is rising and purchasing power is declining due to economic and political policies that are destroying productive forces and undermining productivity. Today poverty is on the rise and so is the food crisis. This great revolutionary crisis has never happened before.

Overcoming the setbacks of the world revolution that has been going on since 1976, there is an unprecedented level of anti-imperialist struggles and world working class revolutions around the world today. This will lead to the outbreak of another series of revolutions. In India, the Maoist parties in the Philippines, Turkey, Peru and other countries are preparing to take advantage of this situation and move forward.

The two factions, which had been at loggerheads since 1871, have been in constant class conflict for the last 150 years. The status of the Paris Commune continues. The working class is ready for the victory of the world revolution.

**Only by reversing
neo-liberal policies
We can save
Visakhapatnam
steel industry!**



The Modi government has decided to privatize the Visakhapatnam steel industry. On January 27, the Cabinet Committee on Economic Affairs (CCEA) decided in principle that it was withdrawing 100 per cent of its investment in the steel industry and its subsidiaries. In line with this decision, government officials also consulted with the South Korean corporate body Posco (Pohang Iron and Steel Company) for the sale of the steel industry. On the other hand, there were some deals with Adani, the chief who represented the Indian Comprador Bourgeoisie. Despite all this, these things were carried out by the steel industry workers, those who were displaced by the industry in the past, and the people of Visakhapatnam without any understanding of their sales activities. But it would be naive for the Jagan government in the state not to understand this. The official announcement of the sale of the Visakhapatnam steel industry for a month and a half came in the wake of all these erroneous transactions. With this, the entire Visakhapatnam city, including the Visakhapatnam steel industry, all on fire with rage. The flames of resentment of the workers, the expatriates and the people were raging.

With the onset of the people's movement against the privatization of Visakhapatnam steel, all the ruling and opposition parties, embodied in opportunism, are vying to support and lead the movement, fearing that they will be left behind. Virtually all of these parties are blowing the whistle on domestic and international corporates. Nor are they opposed to privatization as part of neo-liberal policies.

However, all these parties have noticed the mass movement that has started on a large scale against the privatization of Visakhapatnam steel and are also coming forward in support of the people's movement to monetize the upcoming elections and compete for leadership. With such an opportunistic tendency, all the ruling and opposition parties, including the BJP, are worried about the privatization of the Visakhapatnam steel industry. The Andhra Pradesh Chief Minister is expected to pass a resolution in the Assembly and send an all-party representation to the Prime Minister. He also wrote a letter to the Prime Minister.

Despite the outcry of all the parliamentary parties in the state, the Modi government, aware of the nature of those parties and the personal weaknesses of their leaders, will not give any leeway in its decision. Finance Minister Nirmala Sitharaman directly answered questions from YSRCP and TDP MPs in Parliament on the privatization of Visakhapatnam steel. She said the privatization of Visakhapatnam Steel would lead to industrial expansion, capacity building, use of modern technology and better ownership practices, which would increase mass production and productivity as well as direct and indirect employment opportunities. But it does not say why the government has not been able to achieve all the progress that privatization has achieved while maintaining the Visakhapatnam steel sector. Modi went a step further and said in a webinar on 'Management and Privatization of Public Assets' that "50-60 years ago, public sector companies were good, but now they are outdated and the government can not bare their burden, so the public sector must be privatized in the changing global context." All public sector undertakings (PSUs) except for a handful of companies in the four strategically important sectors (nuclear – defense - aerospace sector, transport, telecommunications, electricity – fuel - various minerals, banking-insurance-financial services) Announced that it would sell. He explained that even in companies belonging to strategic sectors, government involvement is minimal. He said through the sale of PSUs, the government's intention was to raise Rs 2.5 lakh crore and the public needed to be 'benefited'. In summary, Modi said that 'the duty of the government is not to do business, but to inspire trade and commerce'.

With the release of Nirmala Sitharaman's statement in Parliament and mainly Modi's webinar statement, the BJP and YSRCP parties in the AP have started pressing the snare drums. Since the issue of privatization of Visakhapatnam steel is part of the central government's policy decision, privatization is inevitable as the industry is also running at a loss, but there are deceptive comments that the central government will take appropriate decisions to benefit the surviving workers and other workers. Although AP Chief Minister Jagan had earlier rallied against privatization, he took a step back with the Prime Minister's statement and told the leaders of the Visakhapatnam struggle committee that 'the steel plant can sell the remaining 7,000 acres and pay off the debts'. He also

hinted that 'steel plant shares could also be listed on the share market'. These mid-term advice and suggestions given by Jagan are ultimately useless except for the privatization of the Visakhapatnam steel plant. In past agreed to give the family a job as part of compensation for the displaced who lost their livelihood by giving up houses and farms to build the Visakha plant. A total of 16,500 families have been issued 'R' (Rehabilitation) cards. Only 8,500 people got jobs in these 40 years. The remaining 8,000 have not yet found jobs, although generations have changed. Jobs did not come but the 'R' card was transferred from grandfather to father and from father to grandson. To whom does the free advice given by Jagan to sell lands without considering these things work? What will happen if Visakhapatnam Steel Plant shares are listed? Shouldn't the public sector company Hindustan Zinc, formerly based in Visakhapatnam, have started selling 10% stake in the industry and completely handed over the zinc industry to Vedanta Corporate Company! Today the Vedanta company is closing down the company, streetening the workers and doing real estate business with the lands belonging to the company, earning hundreds, thousands, crores of rupees or so! Do not even fly to Visakha steel tomorrow! Despite all these facts, Jagan demonstrated his comprador buracratic bourgeoisie, feudal class mentality by throwing out a free advice that would not embarrass the central government.

Chandrababu, who is the opposition party in the state, reacted angrily to the central government's announcement on the privatization of Visakha Steel, saying, "Visakha Steel has been sold under the rust and has become a hub for the real estate business." In fact, Chandrababu brought neo-liberal policies such as liberalization, privatization and globalization into Andhra Pradesh in the name of 'development' and acted as a broker for domestic and international corporates to plunder the state's natural resources and manpower. Today, all the leaders of Telugu Desam, including Chandrababu, want to give their lives in the ongoing movement against the privatization of the Visakhapatnam steel plant. All this is a drama. All this commotion is a circus feat to increase their vote bank by the time of the upcoming Parliament and Assembly elections. Fighting people have nothing new to expect from the Pawan Janasena party, which has a strategic alliance with the Brahminical Hindutva fascist BJP.

Challenges ahead of the Visakhapatnam steel plant movement

Today there are many challenges ahead of the public movement that started against the privatization of the Visakhapatnam steel plant. While it is a challenge for all the parliamentary parties that are already waiting like foxes to infiltrate the movement and water down it, it is an important challenge to drive the movement with a clear political goal. This is because it is not possible to protect the Visakhapatnam steel plant

without running a movement against the political background from which the Visakhapatnam steel privatization issue arose. Left parties, which already play an important role in the movement, are dealing with a random tendency that is limited to the problem as their trade unions do without a clear political goal for the movement. To avoid this danger, the problem must go to the political roots. Since the independence of the country, all the bourgeois parties in power at the center and in the states have been serving the imperialists, the Comprador Buracratic Bourgeoisie and the feudal classes. They have been making only policy decisions that serve the economic and political interests of those classes. As Modi said in the webinar, public sector industries under the age of 50-60 are good and necessary. Because they served the profiteering, Comprador Big Bourgeoisie to reap the benefits. Although Modi obscured this fact, it remained before us as a historical fact. At that time there were no investments in the Indian Comprador Buracratic Bourgeoisie to set up large industries for the manufacture of capital goods (machinery, etc.) or to dig large mines. So the state itself set up state-owned heavy industries and mines with the people and provided the raw materials cheaply, along with the investment goods needed by the Comprador Buracratic Bourgeoisie. In this order the CBB (Comprador Buracratic Bourgeoisie) of the country became very powerful. On the other hand, by the late 1980s, the Indian economy was mired

in deep debt. To get out of this debt trap, then Prime Minister PV Narasimha Rao and Finance Minister Manmohan Singh for a loan from the imperialist IMF. By lending, the IMF has placed precarious conditions to plunge the Indian economy into imperialist globalization trap. In fact, although these conditions are a stumbling block for the Indian people, the CBB (Comprador Bureaucratic Bourgeoisie) of this country is the in the advantages position. It is against this backdrop that the CBB class in this country, as part of the IMF stipulations, has become a beacon for the investments of the imperialists who have been diverted into the country in the name of neo-liberal policies, while on the other hand, collaboration with capital has become a 'giant' by squandering the country's wealth like a pig. Under these circumstances, it wants to take over all the big industries that are now public sector entities. That is why the Modi government is prepared to privatize all public sector enterprises, whether strategic or non-strategic, at the behest of the CBB. But privatization has been hurting public sector companies with a strategic focus on empowerment. In fact, BSNL, which was PSU in the communications sector till 2009, was profitable. But since the Congress regime began to push the BSNL into a trap of losses, the order has intensified under the Modi government. In particular, Mukesh Ambani-owned jio has undermined BSNL according to a plan to prioritize. Although it had large assets, the banks did not lend. Deliberately stopped modernization. Yet with the plan to privatize many PSUs they have to implement their own plans. Appointed by E.O. Today, despite the insistence of local officials and workers that Visakhapatnam Steel should have separate mines, it is now showing that it is running at a loss regardless. Steel plants with own mines, iron ore at a cost of Rs. 1600-1800, Visakha steel is priced at Rs 5000 is going to cost. This is not the kind of discrimination that is being shown on PSUs today. This discrimination dates back to the reign of Congress governments after the onset of globalization. It gained more momentum during the Modi government. Despite the conspiracy to privatize state-owned enterprises, only 43 of the country's 366 PSUs are running at a loss. However, the Modi government is preparing to hand over the PSUs to domestic and international corporates, pouring in stale water so that they cannot bear the burden.

However, the establishment of PSUs at that time and the privatization of them today are not enough to drive the country's economy on a path of development, only for the benefit of the CBB, the exploitative ruling class of this country, and the imperialists who own it. From then until today, all

the policy decisions made by the ruling parties are for the benefit of the comprador buracratic bourgeoisie, the feudal classes and the imperialists who are their masters. These facts have become so ingrained in the public consciousness today that people participating in public movements are openly saying that government ordinances and laws are not being drafted in Parliament and are being drafted in the official residences of Ambani, Adani and other CBBs. If things are so clear, the Modi government is likely to spend Rs 2.5 lakh crore on public welfare from the sale of PSUs. None of this is true, and it is clear to the public that the funds will be diverted to the CBB industry in the name of stimulus as part of a boost to trade and commerce.

In view of the above, the movement that started in Visakhapatnam should have the immediate task of protecting the Visakhapatnam steel plant, as well as the ultimate goal of reversing neo-liberal policies and establishing a true democratic system in the country. Contrary to this political perception, the revisionist and neo-revisionist parties in the country have plunged the working class into financial ruin. The working class in the country has been subjected to political stagnation due to their insolvent politics. At a time when the rights and values that the people have fought for and achieved under the Modi government are being eroded and the legislation (fascism) is hanging like a sword on the throats of the people that the interests of the exploiting classes should be considered as the interests of the people, there is an urgent need for the Visakhapatnam Steel Movement to unite all the mass movements and move forward as a political entity.

Another important challenge facing the movement is that the statewide response, cooperation and solidarity for the achievement of a steel plant in Visakhapatnam in the 1960s does not appear to be defending the Visakhapatnam steel plant today. This is also true to some extent. The scandal that erupted over the acquisition of a steel



Guntur, Visakhapatnam and many other cities were overwhelmed by student concerns. That is why the movement continued like a widespread, militant and the central government bowed its head. On April 10, 1970, Indira Gandhi, the then Prime Minister, announced the establishment of a 'steel industry' in Visakhapatnam. The steel plant was officially commissioned in August 1992 for 2 decades thereafter.

plant in Visakhapatnam under the slogan 'Visakha Steel – Andhra's Right' took place in the 1960s. The 1960s have gone down in history as the decade of movements with democratic consciousness of the people not only in the country but all over the world. It was during that decade that the 'Naxalbury Armed Peasant Revolutionary Struggle' became the spring thunderstorm in India. In these democratic and revolutionary struggles, the people rallied with great democratic and socialist consciousness. The 'Visakha Ukku - Andhras' right' movement was similarly motivated. The movement received active support from the people across the state. In October 1966, Tamanampally Amritarao of Guntur district went on a hunger strike and an indefinite strike began. Nine people, including a 9-year-old boy, were killed when police opened fire on a crowd of 3,000 on November 1. This brutal massacre by the police did nothing to stop the fighting people. The movement spread across the state. In many places people have clashed with the government and its police. Hundreds of students clashed with police in Mahabubnagar district on the occasion and 20 others were seriously injured. Saireddy was killed in a police firing in Jagityal. In all, 32 people were killed in police firing during the movement. Under pressure from the people, 7 MPs and 67 MLAs resigned. Hyderabad,

Today, if the same steel plant is privatized, there will be a lack of openness, co-operation and solidarity among the people as there was then, and there will not be enough support for the current movement. It is also true that there is a physical basis for their concern. At present in the state there is not only geographical division but also mental division among the people of Rayalaseema, South Coast and North Coast. Such psychological division extends not only to those three areas but also to smaller areas, to different distinct social sections. The postmodernist ideology that has pervaded the state since the 1990s has had an impact in limiting people to such narrow frameworks. In fact regions, entities such as separate social sections, existential consciousnesses, their struggles are those that existed to a great extent even before that. But it is the postmodernist ideology that has pushed them into the narrow framework, the illusions of parliamentary politics. It is postmodernism that has disunited the oppressed and alienated them from the democratic and socialist consciousness. It is also a postmodernist ideology that combines a harmonious attitude towards an anti-development, reactionary state. This was accompanied by revisionism. Hence it is a theoretical problem. This problem also remains a challenge to the 'Save the Vishakha steel' movement today. Theoretical struggle is also needed to meet this challenge. The working class, which is at the forefront of the 'Save the Vishakha Steel' movement today, needs to work hard to unite the broad oppressed masses based on their class ideology, Marxism, and its principles. Only then will the postmodernist bourgeois ideological influence gradually mitigate from the masses, with the formation of the unity of the oppressed masses and the struggle progressing militantly.

And finally the most serious challenge facing the movement is fascism. The Modi government is trying to make the country a safer market for international and domestic corporates, especially Ambani and Adani. Making the necessary laws so that there should be no barriers like theirs in this safe market. Not to mention the demonitization, the GST, the three farm laws, the transfer of 44 labor laws to three codes, the privatization of banks and the privatization of PSUs. On the other hand, the peasantry,

workers, employees, students and people of various sections are protesting against these laws unprecedentedly. Those movements are taking on a nationwide, militant nature. This condition is an expression of the severity of the social crisis. Modi has already launched several 'mantras' to address this social crisis. All failed. He is still preaching 'Development Mantra' and 'Atma Nirbhar Mantra'. People also understand the basics of this. The remaining alternative to exploitative regimes in such circumstances is to try to bring about an artificial, forced unity in the name of religion, race and 'patriotism', to provoke emotions in the masses, and depend up on these artificial and forced unity to create India as a safe market (New India or Hindu state) for the CBB, and the relentless repression of those who oppose the process. This is called 'fascism'. This sequence has already begun. The Modi government, working under the guidance of the RSS,

on the one hand, is inciting Brahmanical Hindu bigotry, Hindu cultural nationalism and patriotism among the people, and is implementing pro-imperialist and anti-democratic reforms most cautiously, keeping in mind a mob formed among the people based on them. On the other hand, it is severely repressing workers, peasants, dalits, women, religious minorities, oppressed races, democrats and intellectuals who oppose its policies. Making the most brutal attacks on public movements, on revolution, on racial struggles. Already, the NIA is sharpening its laws against extremist fascist organizations such as the UPA. On the other hand RSS, Anti-Hindu social fascist organizations like VHP and Bajrang Dal are petrifying. This trend is likely to grow even faster. Under such circumstances, even if the 'Save the Vishakha Steel' movement is to succeed in any public movement, the relevant

leadership must be prepared in every way to face the challenge of fascism.

Conclusion

The proletarian class, which is at the forefront of the 'Save the Vishakha steel' movement, must remember its historic duty on this occasion. In the present circumstances the 'Save the Vishakha Steel' movement is not only possible on that demand, unless possible to fight with the people there, the success of that movement is based on facing many challenges as mentioned above. It is also based on coordinating the ongoing protests in the country and creating a peoples tide. The success of the movement is also determined by the immediate and ultimate goals of the movement. Let us hope that the proletarians of the 'Vishakha Steel Industry' will make progress by making these duties and objectives part of their historic duty!

People's upsurge in Telangana – State repression

SAMADHAN-PRAHAR strategic offense on Telangana is continue in many directions as part of its goal of eradicating the nationwide revolution. The application of LIC operations here is in the development stage. Currently the enemy is devising several attack schemes for achieving target. The Communist Party of India (Maoist) forces have been active in Telangana while the ruling class parties in the state are simmering among the people. Noticing that people waiting for the party leadership were attracted to the party, the government went down a serious repression to thwart the party.

It is against this backdrop that the TRS government is intensifying brutal detention. In the process, the DGP himself oversees the revolutionary area on the orders of the Chief Minister K. Chandrashekar Rao and the SIB and Greyhounds continue to carry out large-scale raids without interruption by the police. As part of this, encounters, false encounters, arrests, propaganda, deployment of forces, joint operations, area domination, reforms, road construction, expansion of communications, strengthening and enforcing a variety of repressive methods are carrying out by state.

As part of maintaining peace and security in Telangana across the state, there were 45,817 policemen for a population of 3,50,03,674 in 2017, while at present there are 65,159 policemen working in Telangana, including Civil and Armed. Including the newly formed Commissionerates, there are 18 Commissionerates, 28 District Superintendents and 13 Armed / TSS SP / SPB Headquarters. There are 164 sub-divisions of all divisions, 185 circle offices and 538 police stations. As of 2017, there were 29,290 policemen in the civil sector, from constables to DGPs, and there are now 34,334 policemen with recruitment since then. As of 2017, there were 16,625 Armed / APBs and 30,825 after recruitment. (From a recently released statistics book by the government)

The above calculations include special forces such as the Greyhounds. Apart from police stations, CRPF and COBRA camps have been set up to control Maoist party activities on the Telangana – Chhattisgarh - Maharashtra border and to protect the construction of projects. They are not specified within the state. They are still recruiting in 12 batches to complete police recruitment based on unemployment. Blue Coats, She Teams, Lake Police, Drones.

As a result, police constables and officers are increasingly being recruited.

After the formation of the state of Telangana, the administrative station of the government and police administration increased due to the geographical changes of the districts and zones. Police officers were concentrated, especially in Maoist-affected areas. In the past OSDs were specifically assigned to eradicate the movement and were abolished after the movement was damaged. Back now the OSDs have been re-employed. AAP and DSP were appointed at the rate of two along with the usual police officers. Apart from these, intelligence officers were also assigned. Retired officers with experience in exterminating the revolution are being re-appointed on a temporary basis. It also includes technicians.

The TRS government has launched a plan to eradicate the Maoist party in Telangana. First came the attacks on mass organizations. More than 20 people have been arrested and jailed for being active leaders and activists of public mass organizations leading people struggles. Hundreds of community leaders, militias and civilians were arrested and imprisoned. The Unlawful

Activity(Prevention) Act (UAPA) is being prosecuted on charges of promoting Maoist ideology, strengthening mass organizations, recruiting into the party, collecting party funds, smuggling ammunition and other anti-government activities. The 16 mass organisations have been unconstitutionally banned for allegedly collaborating with the Maoists. The names of all those working in the villages are being publicly advertised in the media and warned. People who are fighting for democracy are being intimidated.

On the other hand, they are launching a vicious attacks on the party and its leadership, undermining public relations, diluting revolutionary politics to separate the party from the people, weakening public confidence in the Maoist party. Part of the psychological war is that the country is economically too developed and that revolution in a democratic country is unthinkable. In the absence of Naxalism, the development of the welfare state in the state of Telangana is rapidly accelerating. Police are holding public meetings in villages to intimidate people into giving information or taking legal action.

People in the villages are sheltering the Maoist squads without believing the false propaganda of the police. People in several villages are turning against the police who came to combing, police raids on villages, raids by forest officials and arrests. In the united Adilabad district, people from Addala Thimmappur, Thokkiguda, Chorupalli, Mangi Pathagudem and villages were pelted with stones and sticks. People are protecting squads from police raids and providing food. When the squads goes into the village all the villagers invite the squads to participate in the meeting. Knowing this, the government and the police launched a smear campaign against the Maoist party.

Traders, engineers, doctors, people are being terrorized. SIB police continue to commit large-scale mischief through social media. The bourgeois media further highlights this vicious propaganda and provokes governments and the police to share in the repression.

The leadership of the Central Committee, along with Ganapathi, and others are succumbing to illness and contradictions, going

to be surrender and continuing a conspiratorial campaign aimed at the leadership.

In addition to bad publicity, enemy armed attacks have also intensified. The TRS government has taken up the challenge that the squads of Maoist Party are strengthening the cohesive power of the people in the process of developing the guerrilla zone. Carried out repressive operations to exterminate the troops and severely increased the detention. During the months of September-October, the DGP himself visited Kumuram Bheem -Asifabad, Mulugu and Bhadradi -Kottagudem districts in the movement areas and directed armed attacks. DGP stayed there for 5 days in Asifabad district and deployed thousands of troops in the forests. During the three months from August to October, the troops were ... pierced. In four incidents, 8 comrades were arrested, tortured and shot dead in the name of fake counter-fire. A total of 10 comrades were killed. 5 encounters took place. Adilabad, Mangi Area A woman named Ramba Devi was allegedly beaten by a Maoist. Yet in many places the troops were out, noticing in advance the siege of the enemy.

Fake encounters, firing, deployment of enemy forces, arrests, visits by police officers in revolutionary areas, special rallies, cordon searches, checks' scandals have become a hot topic every day across the state, creating terror and confusion among the people.

The surveillance system has been expanded. CCTV cameras are correcting mistakes while strengthening the informer network in every village.

The couriers who are secretly arrested and turned into covert. Fruits, dried fruits, medicine, and other foods brought in by them (along with toxins) can cause chronic illness or even death. A similar poisoning took place on the Wajedu - Venkatapuram squad in October. Became long ill as a result.

the common goal of the exploitative ruling classes is to eradicate the Maoist party which is fighting against the policies of exploitation, the squads which are fighting on behalf of the people and the pro-democracy activists. No matter how many contradictions and squabbles exist between the ruling parties, they are united with a single understanding to suppress people's movements. It was also announced that the SAMADHAN-prahar operation would

KCR fascist rule unmasked by banning the 16 democratic mass organizations in Telangana!

The government of Telangana on March 30, 2021 issued a notice a notification (GO. Ms. 73) banning the 16 mass organizations under the public security Act, 1992 declaring them as 'unlawful associations' and frontal organizations of banned CPI(Maoist) party. Which was made public three weeks later April 24, 2021 by chief secretary Somesh Kumar. The ban will be continued for one year under UAPA- Unlawful activities (prevention) Act. These organizations are Civil Liberties Committee(CLC), Telangana Praja Front(TPF), Adivaasi Organization' Tudum Debba', Revolutionary writers Association(RWA), Telangana Asanghatitha Rangam(TAKS), Telangana Rythanga Samithi, Telangana Vidyarthi Vedika(TVV), Democratic Students Organization (DSU), Telangana Vidyarthi Sangham (TVS), Adivaasi students union (ASU), Release of political

prisoners committee(CRPP), Praja kala Mandali (PKM), Telangana Democratic front(TDF), Forum against Hindu Fascist Offensive(FAFHO), Chaitanya Mahila Sangam (CMS), Amurula Bandu Mithrula Sangham (ABMS).

These organizations of Telangana which are fighting for the democratic rights and against exploitation of people for long time. These organizations are firmly stood and lead the 'separate democratic Telangana' struggle from very beginning the movement.

KCR government propagating false propaganda on this democratic organization is to be considered a fascist rule of Telangana Rashtra Samithi with this ban on democratic organizations, Chief Minister KCR he himself removed the mask of 'rule of law' in Telangana state and imposing repression on fighting masses, organizations and

continue from Telangana. Top Telangana and Chhattisgarh police officials met at the Venkatapuram Mandal Center in Mulugu district on 2020 / October / 04 to implement these plans. The meeting was attended by Telangana DGP Mahender Reddy, senior adviser to the Union Home Ministry, Vijay Kumar TG, CRPF DG IGs of CG, intelligence officers and SPs. Discussed issues such as joint operations, coordinating intelligence exchange, providing assistance, blocking all types of logistics as well as financial resources. As per the decision, 5,000 Cobra, DRG and Greyhounds forces attacked the revolutionary camp at Bhattigudem, a Telangana-Chhattisgarh border village. With the support of the people, the Telangana forces escaped the attack. With this, the tribal farmer of the village was shot dead. 6 members of Adivasi's were imprisoned.

A Greyhound constable was injured in a recent retaliation by PLGA forces in Telangana. TRS leader Bishwer Rao, a land guard, landlord, trader and informer, was punished. People from Addalathimapuram and Pocharla villages in

Asifabad district were attacked the Greyhounds when they came to combing.

SI was killed when Greyhounds arrived in combing and opened fire on another Greyhounds team in the Chennapuram forest of Bhadradri Kottagudem, believing them to be Maoists. The head constable, who was combing in the forests of Adilabad, died of a heart attack for fear of attack. Despite the tight repression in Telangana in the name of Samadhan and Prahar, the people are protecting the squads without fear. Fighting against state repression.

The central and state governments have gone berserk for the past few years that the party has been suppressed in Telangana. But after the government and the police were stunned by the party's efforts in 2020, this year the national and state media must also recognize that 'the Maoists are active in Telangana again'. With this, the central and state governments must accept the influence of the Maoists by saying that they will set up a new police training center at Kottagudem and make it a Maoist-free state.

We are appealing to all the representatives and ministers elected from tribal people should condemn this 'barbarious attacks on people and come forward to safe guard the lives and lands of tribal people.


All the parliamentary parties should condemn this terrorist Drone attacks on people. This attacks are eminent danger to the existence of parliamentary parties also.

The conspiracy cases of Bheema koregoan by Brahminical Hindu fascists are fake! *American Arsenal forensics lab report.*

The Modi government conspired and arrested social activists, rights activists, democrats, government critics and progressive forces and put them in jails. The government calling them as urban Maoists and clamped upon them UAPA, SAPTA like black laws.

They put Ronawilson along with poet Varavara Rao, women activists Sudhabhardwaj, Somasen, Vernon Gonsalvez, Arun Pereira, Gautam Navlakha, Surendra Gadling, Sudhir Dhawale, Proffessor Anand Teltumde and 23 personalities in the Bhima koregam false case in 2017 on charges of conspiracy to assassinate Prime Minister Modi and overthrow the government. The activists were illegally arrested and imprisoned. All the allegations that have been circulating for two and a half years have turned out to be fake. Arsenal Consulting, a digital forensics and information security firm based in Massachusetts, USA, released a report on February 10.

With state-of-the-art technology, it became clear how and when false evidence was created with irrefutable arguments. The company conducted several technical tests on a computer hard disk that police say was seized from Rona Wilson, an accused in the Bhima koregam case, and produced a sixteen-page report. The agency described the Bhima koregam case as one of the most serious evidence-tampering incidents ever seen. The company discovered that on June 13, 2016 a malware intruder injected a remote access Trojan into the hard disk they were examining. Malware is malicious software that deliberately sends mail. It comes in the form of an attachment in the mail. Malware usually enters the computer when the recipient clicks on an attachment with the name that arouses curiosity. Takes control of usernames, passwords, and programs related to that computer. This allows the intruder to work on the computer from a distance and

view the work done by the owner to make changes and additions to the computer.

On the afternoon of June 1, 2016, with the help of a remote access Trojan, Ron Wilson received a series of e-mails in the name of his friend, a rights activist (Dube). He said in an e-mail with the activist's name that he was sending a link that contained details and other information to a civil organization and that the link should be downloaded and viewed. Rona Wilson clicked on the link and opened it. The Wilson computer became available to the cyber attacker. The keystrokes password used by Wilson and the amount of browsing activity are known. That's it Based on them, the attacker created a hidden folder and inserted 10 letters in it. Rona Wilson did not know who implanted them until the beginning of the case. The documents were put together with a newer version of Microsoft Word. Arsenal say they are not in the Wilson's system. Arsenal have revealed that the cyber attacker carried out the operation in a very armored manner, leaving no doubt that it took them 300 hours to unravel and analyze the hidden folder. Mark Spencer, president of the agency said.

On March 14, 2018 while Wilson was using his pen drive, intruders inserted an invisible folder in his laptop into the pen drive containing 10 letters accusing him of attempted murder, government demolition and arms collection. Eight of the ten letters were written in English and two in Hindi.

Examining the computer hard disks of the accused also reveals more details about the extent and depth of the intrusion. Supreme Court and High Court judges, some current judges,

independent observers and journalists have argued that the evidence in the case is false and a fabrication of the police. A question was raised in Indian Parliament regarding cyber-attack on Rona Wilson's computer, but there was no answer from the government.

There were also cyber attacks on three celebrities who were helping those in jail legally. In 2019, Amnesty International publicly proclaimed that the attack was carried out by a government agency. In response to the Bhima Koregaon conspiracy case, members of the American Bar Association, the United Nations, the Human Rights Commission and the United States Congress condemned Modi's actions and demanded their release from jail.

In a series of conspiracies, massacres and atrocities committed by the Brahminical Hindutva BJP and the Sangh Parivar forces. These fascists are experts in committing these massacres. Bhimakoregam case is not the first and not the last.

The Brahminical Hindutva forces in the country demolished the Babri Masjid by placing idols of Lord Rama in the Babri Masjid and propagating that it was a Rama Mandir. Thousands died in the riots. Thousands of Muslims have been killed in a religious riot in Gujarat over the alleged burning of a train car in Godhra and Dalit Christians have been set on fire in the Kandhamal area of Odisha. Social activists, rationalists and writers Govinda Pansare, MM Kalburgi, Narendra Dabholker and Gauri Lankesh were assassinated by Sangh Parivar forces. These are just a few spots. Life is not enough to write down these fascists atrocities and conspiracies.

Soon after the Brahminical Hindutva BJP came to power at the Center, they appointed Safron elements in Army, Navy, Air forces, Judiciary and key administrative posts. By this way the fascists captured all the important posts and kept under their control. They are provoking chauvinism with sentiments and emotions and diverting the people's mind from real problems they are facing. It abolishes Articles 370 and 35, which confer autonomy on Jammu and Kashmir, divides Jammu and Kashmir into two Union Territories and oppresses the people of Kashmir with paramilitary forces. Brahminical Hindutva fanatics continue their fascist repression of the oppressed Nationalities of the Northeast. The Babri Masjid verdict in the Ayodhya case was completely biased. They are killing and lynching Dalits and Muslims and giving slogans like Jai Shriram and Bharat Mata Jai. By bringing CAA, NRC, NPR laws, they are conspiring to nullify the citizenship of Muslim, Dalits and Tribals. These fascists are attacking Jamia miliya and JNU students who are fighting the fascists.

In face of Corona crisis opportunity, Modi government amended the 44 labor laws and made them into 4 codes. Betrayed the peasantry in the name of new agricultural laws. Hundreds of social activists, intellectuals, workers, peasants and student movement leaders who fought to repeal anti-democratic laws were portrayed as traitors and imprisoned. Fascist repression continues as paramilitary forces deployed on Maoist movement areas, attacking tribal villages, killing and assassinating women, and telling to neutralize the Maoist movement by 2022. On the

direction of Modi & Amith shaw, the repressive state machinery in the leadership of Ajit Doval and Vijay Kumar attacking the democratic and progressive forces across the country.

Protests and bandhs have been held across the country and around the world demanding the unconditional release of rights activists who were illegally arrested in the Bhima koregam case. However, Brahminical fascists do not have a minimalist humanitarian nature. The Modi government is conspiring to kill in jails despite the Supreme Court order to take any immediate action against the accused in the Bhimakoregam case.

The Arsenal Consulting report revealed the conspiracy, including the evidence. Forensic experts have confirmed that as soon as the Arsenal report came out, the government went into defense and the Ronawilson hard disk contained enough basic evidence of crime, according to National Research Agency (NIA) spokes woman Jay roy with loud mouth. No matter how many conspiracies and intrigues the Modi government has committed, it must fall into the realm of real democracy like fire.

The in spite of conspiracies, the leaders of the movement put in jails, should be released by mass movements. Movements transformed into PLGA and do release the jailed leaders and activists. Formed into a people's army, they destroyed and liberated prisons. Bhima koregam Political prisoners are once again being hailed by people and democrats around the world. Truth wins. Dungeons and gallows do not stop the revolution, the aspirations of Bhima koregam prisoners will be realized by the fighting people.

Apple Vestron workers in India in struggle

The incident in Apple Vestron I Phone Company in Narsapura in Kolar district of Karnataka in India is one more example of neo-colonial form of exploitation and the resulting struggles that are going on all over the world. It also exposes why the Indian exploitive ruling classes annulled the 44 labor laws and brought forth 4 labor codes. "The Taiwan based US Company established its branch with an initial cost of Rs.3000 crore rupees and started production in 2020 July. There are ten thousand workers in the Assembling plant out of which 1343 are permanent and 8400 are working as casual workers under 6 contractors. The Company appointed the workers irrespective of educational qualifications. The workers include ITI, Diploma holders and University educated, all of them working with a monthly salary of less than Rs.15000. Workers lack facilities in work place, proper payment and security of job. Women workers are made to do night shift.

Workers have a break of 30 minutes to have food and 15 minutes for having tea in the 8 hour shift of a 6 day week. The Managers monitor the work through nearly 454 CC TV cameras. Since October the working day was extended to 12 hours of a 5 day week. There was no payment for Over Time. Those who worked without taking leave for one month were given an incentive of Rs.1000. The move corresponded with the Central government ordinance of 4 labor codes. The Karnataka state government was one of the 10 states that immediately banned labor laws for three years and increased the number of working hours. Basic benefits for the workers were cancelled. Workers of Vestron Company demanded the management several times

for payment of wages in proper time and payment for OT. But the Management suppressed them by deploying police forces with the support of the government. Discontent was brewing among the workers. The workers of night shift on 11th December realized that less than Rs.500 was accounted in their deposits. The next day they met the Management and requested them to immediately pay their wages. But the management called the police and threatened the workers. The angry workers attacked and destroyed the Assembling department and Management office. They declared that they would take up struggle if their wages were not paid. The Company stated that it faced a loss of Rs.437 crores due to the attack. "The Modi government responded immediately. It issued directions to pay the workers and take action on the workers who attacked. It also stated that such incidents shall affect investments of foreign corporate enterprises in the country. The Karnataka state government arrested 167 workers of the Company. It foisted cases on hundreds of them and the police started searching for them creating terror. Many workers left the place. A large number of workers were removed from the Company. "A joint committee of 7 Trade Unions of the state condemned the repressive measures on Vestron workers. Various opposition parties and rights organisations also condemned the measures. Then the Management came out with a statement that there was a loss of only Rs.50 crores and asked excuse for not paying wages in time. "The incident appears to be a minor one but reveals a major issue in discussion. The world shall witness many such small and big struggles in the coming times.

Women have been raped and killed, arrested and tortured, destruction of public property and looting of property. On the one hand it is said to be development while continuing the violence in this way and on the other hand carrying out the construction of roads under police protection in the name of development. If the people's governments run schools and hospitals for welfare, the government will destroy them and the Maoists will be seen as impediments to development. There is a large-scale agitation across the Dandakaranya against the police camps and the stalk of government sabotage. They want 'schools, hospitals' not police camps.

When the pro-imperialist, anti-people fascist Modi government and congress Bhupesh Baghel state police forces came under attack on April 3, 2021, the PLGA forces retaliated against them. In this daring counterattack, 28 policemen were killed in a resistance by the PLGA against thousands of mercenary police forces. One was found captive. More than 30 people were injured and the rest fled. Earlier, Jiragudem villager Madavi Sukkalu was caught, tortured and taken away with them. Later he was released.

Four PLGA fighters fought heroically and were martyred in the attack. 1. Comrade Odi Sanni 2. Comrade Paddam Lakma 3. Comrade Kovasi Badru 4. Comrade Nupo Suresh. Guerillas could not bring the body of Comrade Sunny. The other three underwent a final

reform, with revolutionary traditions among the revolutionary people, saying the revolutionary salutes.

In the seven years since Modi came to power, the financial crisis has intensified and the political situation has deteriorated, endangering the lives of the people and the wealth of the country. The government is continuing its fascist repression on all organizations, on all communities across the country, on Dalits, tribals, religious minorities, women, workers, farmers, employees, students, democrats, on mass organizations. The Modi government's attacks on struggling intellectuals and democrats in the name of 'urban Maoists' and finally on leaders of bourgeois parties are on the rise. They are weakening all constitutional systems and legitimizing fascist rule by giving them wider powers. Themselves branded as patriots.

Across the country, people in the jungles and plains are fighting under the slogans of Jal-Jungle-Zameen-Izzat-Adhikaar, protecting natural resources and wealth. They are true country patriots. The CPI (Maoist) is providing leadership to those struggles and is taking those struggles forward militantly. Running people's struggles, guerilla war. No matter how many demonic assassinations Modi and Amit Shah plot, let's defeat them all through a people's war.

People from different walks of life and sections of the

country who have been subjected to brutal attacks by the central and state governments in the country have invited and the PLGA attack is the right answer to the fascist rulers. They declared their faith in the Revolutionary Party and the PLGA. Revolutionary enthusiasm doubled in the revolutionary ranks. It was created the panic among the mercenary forces. On war foot Amit Shah came to Basagudem in Bastar, Jagdalpur on deep clouds. He went to Raipur with instructions for a review. Amit Shah, the Union Home Minister, a key leader in the BJP and a virtuoso in conspiracy politics, has lost his temper. He says repeatedly that the forces did not damage the psyche. He is shouting (alone) that he will crush the Maoists. The well-being of the people and the future of the country is not a priority for the soldiers who work for salaries. For the people, the confidence, courage and self-confidence of the Maoists working towards the liberation of this country are paramount. They are full of revolutionary politics. There have been many sacrifices in the decades-long history of revolution from Naxalbury to the

present day. The valuable histories of the martyrs contributed greatly to the development of the movement. Who is working for whom, who is fighting for what goal, who is willing to sacrifice. This is the priority. The need is clear to the oppressed people. No matter how many lies were told by the exploiting media, it did not hide the reaction of the real people. Did not cover up the fears of the rulers. That blow could be in one place. But it was the collective response of the oppressed people of India. That resistance came with the response of the people. As well as recorded in history.

As the financial crisis intensifies inside and outside the country, the financial crisis in the country intensifies into a political crisis and internal squabbles within the BJP and opposition parties intensify, with the BJP failing miserably at the failure of both the Hindu fascist scheme and the police strategy.

The morale of the police was damaged. Super Cop Vijay Kumar, KS Gill as a condition of the house pushed thereon. No matter what Ashok Juneja says, Kuldeep Singh has two options, “whether the Maoists will die or flee”, but in the end what will happen. The end of the exploitative classes, the victory of the oppressed people.

Exploitative regimes follow fascism to get out of the economic crisis and political crisis. They rely mainly on the police and military. Amit Shah, who has now gone insane with his own blow, came to Raipur

from Assam via Delhi. He wanted to increase self-confidence in the police visiting with rush around Basagudem to Jagdalpur.

Everyone understood that Shaw, who had lost his self-confidence and he was shocked.

No matter how many schemes like Salwajudum, Greenhuant, Samadhan, Prahar are written as part of the LIC strategy, it is inevitable that the politics of civil war will be scrapped. The people will continue to resist in various forms as long as they continue to exploit the people’s labor power, national wealth and oppression as their exploitative class rule. The turmoil in the Modi-Shaha alliance has begun. The Gujarat massacre, the Babri Masjid demolition, Corona waves, the deteriorating situation in the country during the last 7 years of rule. People from all walks of life are facing difficulties. Therefore, these types of resistances play a sufficient role.

Amit Shah speaks military language of war, attack, Prahar. Our counter-attack, resistance, self-defense approach only. People do not want war. If the government declares war it will choose the alternative route. Resist as part of self-defense. The same is being invented in class society for generations.

Rakeshwar Singh Manhas, who was found captive, was welcomed by the people of PLGA and Janata Sarkar. The mediators were honorably summoned and handed over to the press in a public meeting. Until then, the Maoists had

covered up the violence of the ruling classes and were tainted by the propaganda of the ruling classes that they were violent and the machinations of a few opportunists. The Maoists have fabricated false stories that they have killed the police by trapping them, undermining the facts told by the wounded police that we had gone on the attack. “Our cat-mouse game, was that” the actual theatrical Vijayakumar all exposed.

Today people from all sections of the country want Maoist politics as an alternative to exploitative class politics. Are integrated into different organisations. Today the politics of resistance to the country, the ‘Janatana Sarkar’ political governance policy is the only alternative but the only alternative. The country is in the most difficult conditions today. The fascism of Modi and Amit Shah is the most dangerous to the people of the country. In a situation where all constitutional systems have been weakened, in a situation where legal concerns are being brutally suppressed, the only alternative is armed struggle, in which the people’s movement, the people’s war, is in full swing. On April 3, 2021, fascist Modi, Amit Shah and Chattisgarh chief minister Bupesh Baghel, police led by Bastar IG Sundar Raju led a massive attack on villages in Sukma-Bijapur districts with 2000 men under the name 'Samadhan-Prahar'. Came up with an evil plan to eradicate PLGA.

The plan for the massive attacks was decided in August 2020 at a meeting of police officials led by Amit Shah in Delhi. Later, under the leadership of Raipur-based assassin Vijayakumar, a plot was hatched in October in Telangana-Venkatapuram with police officers from 5 states. Bastar Sundararaja was given charge of the Bastar Military

Command. Ashok Juneja (DGP) from the Center has been appointed as the special officer for these attacks.

The attacks, which began in November 2020, have killed more than 150 people, including CPI-Maoist party leaders and activists. Thousands of people were imprisoned.
